

### **PROJECT UPDATES**

# POMINGALARNA MULTI-SPORT CYCLING COMPLEX

The Wagga Wagga Multisport Cycling Complex project was completed in April 2022.



The project is the largest multisport cycling complex in NSW and is capable of hosting regional, state, national and, international events. The project was a collaboration between Wagga Wagga's five cycling groups and the Wagga Wagga City Council and was completed in April 2022.

The project features a fenced children's playground, a mountain bike playground, a new criterium track, jump and pump tracks, a cycling education area, an outdoor velodrome, a BMX track and new car parking and supporting infrastructure.

### RIVERSIDE PRECINCT

The Riverside upgrade which commenced in 2010 was completed in 2022. The development comprised of a regionally significant playground, event spaces, car parking upgrade and a new shared path.

The area is now a key attraction for residents and visitors to the region, and an ideal venue for festivals, markets, and musical performances at the Wagga Beach and Murrumbidgee River Precinct.

The Riverside upgrade was originally designed to reinforce the relationship between the Murrumbidgee River and the City as part of a process to turn "The Bend" into an iconic destination for Wagga Wagga.





### **PROJECT UPDATES**

### RIVERINA FREIGHT AND LOGISTICS HUB

Construction at the Riverina Intermodal Freight & Logistics (RiFL) Hub continued throughout 2021. Stage 1 and Stage 2 of the RiFL Hub are complete, including the 4.9km rail siding connecting the Main Southern Railway to the RiFL Hub.

The RiFL Hub is now operational with VISY Logistics managing and operating the site.

Construction of stage 3 of the RIFL Hubthe Bomen Industrial Precinct adjacent to RiFL - consisting of a 60 - hectare industrial subdivision has commenced. This aspect of the project will allow businesses using the RiFL Hub easy access to the facility.

The RiFL Hub is funded by all 3 levels of government.

### SPECIAL ACTIVATION PRECINT

The Wagga Wagga Special Activation Precinct (SAP), located at Bomen, was announced in 2019. One of six SAPs across the state, the Wagga Wagga SAP's master plan has been finalised, with the precinct now in the delivery phase. Regional Growth NSW Development Corporation provided a draft delivery plan for the Wagga Wagga SAP in April 2022. The Wagga Wagga precinct Delivery Plan sets out criteria for design, landscaping, infrastructure planning, delivery and proposal assessment.

The Wagga Wagga SAP is comprised of five stages, with infrastructure funding committed to the end of Stage A and B. Stage A is forecast to be finalised by the end of 2023, while stage B is expected to be completed in 2025.

The SAP incorporates the Riverina Freight and Logistics Hub and will capitalise on the Inland Rail Project, providing greater connections between Wagga Wagga and the world.




### **ACTIVE TRAVEL PLAN**

The Active Travel Plan consists of 13 cycling links totalling 56km designed to connect the outer suburbs to recreational facilities and the Central Business District.

The Active Travel Plan aims to reduce the number of motor vehicles on the road and to promote and encourage more commuter cycling within the city.

7 of the 13 links are complete and have been opened to the public including the Eastern Levee Link, Red Hill Road link, Kapooka link, Fay Avenue link, Lake Albert link, Wollundry link and Pomigalarna link. Work has commenced on all other links.



### WAGGA WAGGA PCYC

Construction commenced on the new Wagga Wagga PCYC facility in November 2021 and the facility rapidly took shape over 2021-22. The new facility includes studios for martial arts, boxing, dance, and yoga, a public café, conference and meeting facilities, an out-of-school-hours-care center, a youth drop-in hub, and over 100 undercover parking spots.

Older residents will be supported with gentle movement sports, exercise programs, and activities such as pickleball.

The club will offer a driver education program, extensive school holiday activities, various court sports for both adults and youth.

The \$23 million project was completed in late 2022 and providing a state-of-the-art sport, recreation and youth centre for use by everyone in the Wagga Wagga region.
